The provider will share his/her opinion with you and when indicated, will recommend a treatment plan or advise you of the need for further testing or surgical procedures. Please use this opportunity to ask questions. It is our experience that the patients who respond the best to treatment are those who are participants in their own health care. You can help in this evaluation process.

## Things to bring with you or send in ahead of time:

- Copies of pertinent medical records (labs, X-rays, etc...)
- Completed Health History Form (enclosed)
- Completed and signed Registration Form (enclosed)
- Completed and signed Privacy Practices Acknowledgement Form (enclosed)
- Current Photo ID, Insurance card(s) & Co-Pay
- COVID-19 Vaccination card if you've been vaccinated

## Helpful things to know before your appointment:

- It is our policy that payment is made at the time of service for your office visit. If you do not have your co-pay, your appointment will be rescheduled.
- We require that you check with your insurance to verify that our providers are in your network. If our providers are in your network you will be responsible for paying your copay amount at the time of service. If our providers are not in your network your insurance may not cover the office visit in addition to any procedures that our providers perform. You will be responsible for the full balance of the office visit/procedures.
- Some insurance companies require a "Referral Authorization" prior to being seen. We require that you check with your insurance to see if a "Referral Authorization" is needed and if so, to verify that one has been issued. Your primary care physician/referring physician will assist you with the Authorization if you need one. NOTE: Not all insurance companies have this requirement, but if you are not sure you should call your insurance to verify.
- **If you are not prepared to pay your copay and/or balance at the time of service your appointment may be rescheduled. If you have questions regarding this please do not hesitate to call us, our office may be able to arrange a payment plan.**

Please expect an automated call from our office prior to your scheduled appointment to remind you of the date and time. If you have questions, concerns, or need to reschedule your appointment please call our office. It is our goal to provide you with the quality service we believe you deserve. We appreciate your participation and look forward to working with you to achieve that goal.

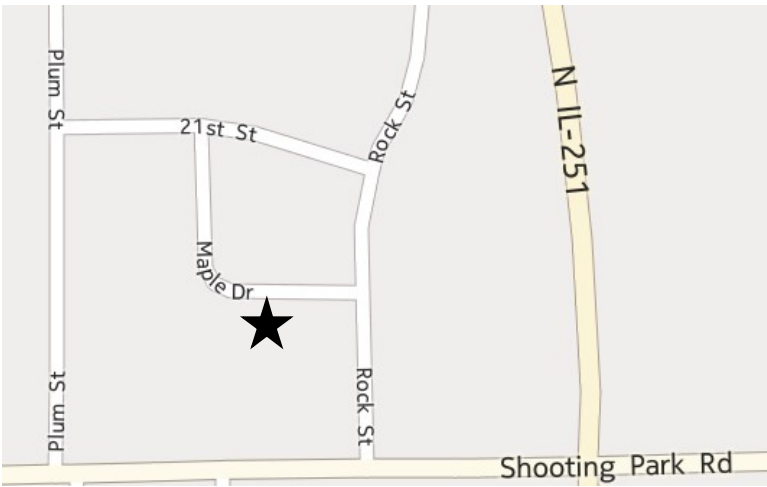

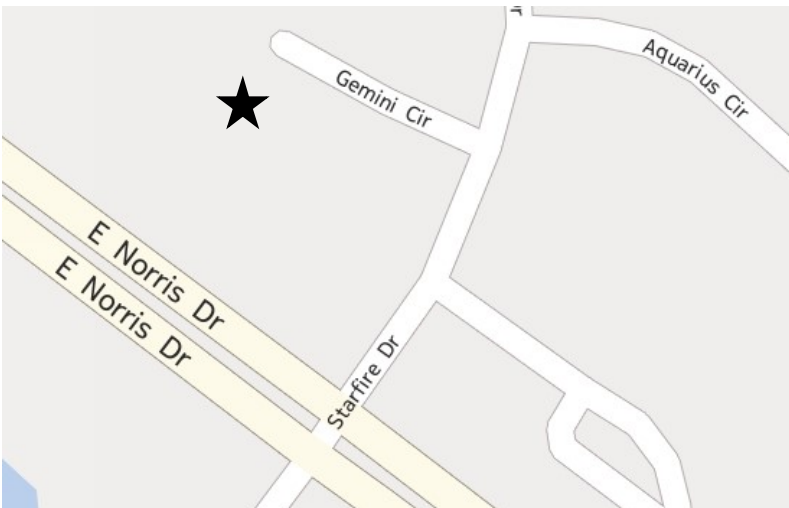
The Princeton office is located at 530 Park Avenue East; second floor of the Medical Office Building, Suite 207, in Perry Memorial Hospital.

From I-80 – take exit 56, turn South onto Main Street. Turn left onto Peru Street (Route 6-East). Turn right onto S. 5<sup>th</sup> Street.

From Route 6 turn South onto South 5<sup>th</sup> Street.
